Same Great Service. New Look.

The City of Traverse City and TCL&P are upgrading to separate utility billing systems, planned for Spring 2022.

What this means for TCL&P/City customers:

- **Water and Sewer utilities** will be billed together from the City
- **Electric utilities** and customers with TCLP *fiber* will be billed together from TCL&P
- Billing statements will be getting a fresh new look
- Enhanced on-line bill payment options

The City and TCL&P are working hard to make this transition as seamless as possible. **Keep an eye out for more detailed information to come in early 2022.**



Free Light Bulbs

Speaking of your new bill, how about some new LED light bulbs? Customers can get free LED bulbs through TCL&P's Energy Saver Program.

In partnership with TCL&P, Green Projects Group has created a Free Lightbulb Program through which TCL&P customers can receive up to **40 LED bulbs**, including:

- **A19 bulbs (for general use)**
- **BR bulbs (for can lights)**
- **PAR bulbs (for outdoor flood lights)**

The LEDs provided through this program are Energy Star approved and use between 9 and 11 watts.

As a TCL&P customer, you pay nothing. All you have to do is fill out the rebate paperwork on the Green Projects Group website, and your LEDs will be mailed to you within 2-4 weeks.

A Clean Energy Future

The Path to 100% Renewables

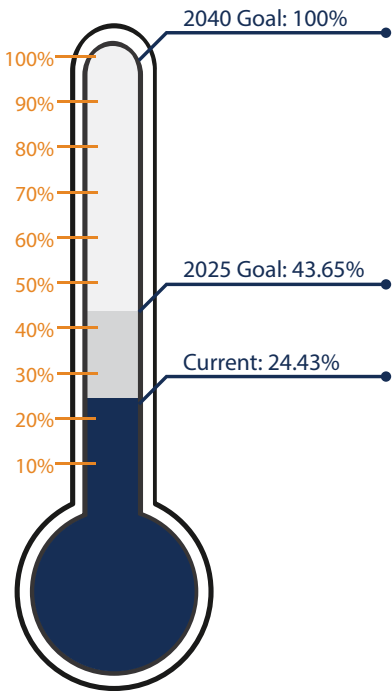
In August 2018, the Board approved the strategic plan goal to have the utility power supply become 100% renewable by or before 2040 with intermediate goals of 15% renewable by 2021 and 40% renewable by 2025. This complemented the City of Traverse City’s commitment to power all city operations with 100% clean energy.

To date, TCL&P is at 24.43% and based on future power purchase commitments in renewable energy in Calhoun and Oceana counties, we anticipate reaching 43.65% by December 2023.

To continue the momentum, the Board will be working with a consultant to create a plan to reach the 100% Renewable Energy goal on or before 2040.

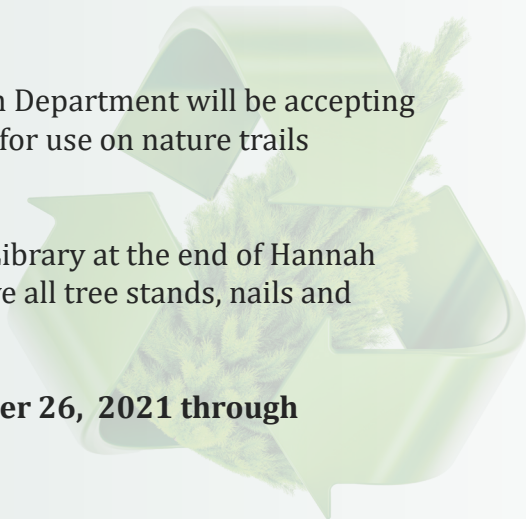


Recycle Your Holiday Tree
